



# Is Your Payment Past Due? We May be Able to Help!

The Governor's Executive Order prohibiting the termination of water/sewer service for non-payment ends on December 31, 2021.

We have partnered with Yuba-Sutter Economic Development Corporation to provide one-time grant funds to offset a portion of customers' past-due balances.

**IF YOU HAVE A PAST-DUE BALANCE, APPLY TODAY  
TO AVOID POSSIBLE FUTURE DISCONNECTION OF YOUR WATER SERVICE.**

### ELIGIBILITY REQUIREMENTS:

You must meet all these requirements to be considered:

- Reside in Yuba County
- Have a past-due water bill (*This program is also available for sewer bills; check with your sewer provider for details.*)
- Household's gross annual income must be **at or below 200%** of the Federal Poverty Guidelines (*Use chart on the right to determine your household eligibility.*)
- Prove a coronavirus hardship
