Dave,

I spoke with Dave Karraker of our East Los Angeles District and he has concurred with my approach to recommending an adjustment to the Projected Imported Water Sales quantity that is included in Central Basins MWD's 2010 Urban Water Management Plan Table 2-3. It is California Water Service Company's corporate goal that we restore the groundwater production capacity in the ELA system so that we can reliably and routinely pumping our full Allowed Pumping Allocation (APA).

That said it is our plan to be able to pump 11,774 AFY by 2015. That represents an increase in groundwater use of approximately 5,000 AFY over what we are currently pumping (6,800 AF in 2010). Therefore, I recommend that you edit your draft UWMP to reflect a corresponding reduction in the purchase of imported water by California Water Service - East Los Angeles / Commerce as follows:

2015	14,700	9,700
2020	15,150	10,150
2025	15,600	10,600
2030	16,000	11,000
2035	16,500	11,500

These values may still be a bit high but they gives us some room to maneuver in accomplishing our all goals by 2015. It accounts for the inclusion of Commerce in our quantity and provide you with a more realistic value. The nice thing about Urban Water Management Plans is they are updated every 5 years so we can make course corrections as needed.

Central Basin Municipal Water District (Central Basin) is now in the process of preparing its 2010 Urban Water Management Plan (2010 UWMP) consistent with the requirements of the statewide Urban Water Management Planning Act of 1983. Central Basin last completed an UWMP in 2005, so this process represents an update of that plan.

Central Basin completed a draft of the 2010 UWMP which was made available in late March 2010. A copy of that plan was sent out to representatives of all cities and agencies in the Central Basin service area with an invitation to provide comments prior to April 30. Concurrently, the draft plan was posted on the Central Basin website (at [http://www.centralbasin.org/press\\_releases/Draft-2010-Urban-Water-Management-Plan.pdf](http://www.centralbasin.org/press_releases/Draft-2010-Urban-Water-Management-Plan.pdf)) for any member of the public that would like to review and provide comments.

Finally, Central Basin is planning to complete the adoption process by holding a public hearing at its June 27 Board of Directors meeting at 10:00 A.M. With all final public comments provided at that time, the staff recommendation will be to adopt the 2010 UWMP and send it to the California Department of Water Resources as required by law.

Attached is Central Basin's Draft 2010 Urban Water Management Plan for your review and comment. You will see that there are large blank spaces on many pages. This is just a WORD document issue and will be corrected in final version. Also, we will be adding a few items to make the document consistent with the Department of Water Resources' "Review for Completeness Form" which will be included in Appendix A. Again, this will not substantially change the document. Finally, the executive summary is not included in this draft, but it will be included in the final document.

In order to meet our deadline of getting this adopted to meet state requirements, I would like to get your comments back by April 27. We plan on completing all the above mentioned changes and holding a public hearing with our Board of Directors in June 2011.

California Water Code, Part 2.6 Chapters 1 through 4 (Sections 10610 through 10656), are known and may be cited as the "Urban Water Management Planning Act."

These California Water Code sections require all urban water suppliers that provide water for municipal purposes either directly or indirectly to more than 3,000 customers or supply more than 3,000 acre-feet of water annually to prepare an Urban Water Management Plan as outlined and identified in those sections. This requirement applies to public and privately owned water utilities.

The plan must describe and evaluate sources of supply, reasonable and practical efficient uses, reclamation, and demand management activities. The components of the plan may vary according to an individual community or area's characteristics and its capabilities to efficiently use and conserve water. The plan must address measures for residential, commercial, governmental, and industrial water demand management.

The act requires urban water suppliers to update their Urban Water Management Plans at least once every five years, and to file updated plans with the Department of Water Resources, the California State Library, and any city or county served by the supplier no later than 30 days after adoption.

California Water Service Company (Cal Water) is an investor-owned public utility providing water service throughout California. In addition, Cal Water is regulated by the California Public Utilities Commission (CPUC).

One of Cal Water's service areas is the East Los Angeles District, which is located in Los Angeles County. The East Los Angeles District serves a large section of unincorporated Los Angeles County known as East Los Angeles, and portions of the cities of Montebello (20%), Commerce (85%), and Vernon (10%).

As a defined urban water supplier, Cal Water is preparing an update to its Urban Water Management Plan that will address the water service conditions in the East Los Angeles District. It is Cal Water's intent to adopt that plan and file that plan as required with the Department of Water Resources, the California State Library, and any city or county within which Cal Water provides service.

A key focus of this UWMP update is the conservation requirement set forth in Senate Bill 7 (SBx7-7) as passed in November 2009. SBx7-7 mandates a statewide 20% reduction in per capita urban water use by 2020. In order to quantify the objectives and identify the means of achieving this mandated demand reduction, Cal Water has prepared a Conservation Master Plan.

Cal Water is in the process of expanding current conservation programs and developing new programs for its 24 districts. Over the next five years, Cal Water conservation program expenditures are likely to increase, due in large measure to recently adopted state policies requiring future reductions in per capita urban water use. These state policies include SBx7-7, as well as recent decisions by the California Public Utilities Commission (CPUC) directing Class A and B water utilities to adopt conservation programs and rate structures designed to achieve reductions in per capita water use, as well as the *Memorandum of Understanding Regarding Urban Water Conservation in California* (MOU), of which Cal Water has been a signatory since 1991.

The Conservation Master Plan for the East Los Angeles District will be presented to the Cities, Counties and public served by Cal Water's East Los Angeles District in conjunction with the UWMP.

Central Basin Municipal Water District (Central Basin) is now in the process of preparing its 2010 Urban Water Management Plan (2010 UWMP) consistent with the requirements of the statewide Urban Water Management Planning Act of 1983. Central Basin last completed an UWMP in 2005, so this process represents an update of that plan.

Central Basin completed a draft of the 2010 UWMP which was made available in late March 2010. A copy of that plan was sent out to representatives of all cities and agencies in the Central Basin service area with an invitation to provide comments prior to April 30. Dave,

I spoke with Dave Karraker of our East Los Angeles District and he has concurred with my approach to recommending an adjustment to the Projected Imported Water Sales quantity that is included in Central Basins MWD's 2010 Urban Water Management Plan Table 2-3. It is California Water Service Company's corporate goal that we restore the groundwater production capacity in the ELA system so that we can reliably and routinely pumping our full Allowed Pumping Allocation (APA).

That said it is our plan to be able to pump 11,774 AFY by 2015. That represents an increase in groundwater use of approximately 5,000 AFY over what we are currently pumping (6,800 AF in 2010). Therefore, I recommend that you edit your draft UWMP to reflect a corresponding reduction in the purchase of imported water by California Water Service - East Los Angeles / Commerce as follows:

5/18/2011

Year	Current Quantity (AFY)	Recommended Quantity (AFY)
2015	14,700	9,700
2020	15,150	10,150
2025	15,600	10,600
2030	16,000	11,000
2035	16,500	11,500

These values may still be a bit high but they gives us some room to maneuver in accomplishing our all goals by 2015. It accounts for the inclusion of Commerce in our quantity and provide you with a more realistic value. The nice thing about Urban Water Management Plans is they are updated every 5 years so we can make course corrections as needed.
